EUNPDC Mission Statement

The EU Non-Proliferation and Disarmament Consortium (EUNPDC) forms the core of a wider network of European non-proliferation and disarmament think tanks and research centres. It is managed jointly by the Stockholm International Peace Research Institute (SIPRI), the Fondation pour la Recherche Stratégique in Paris (FRS), the International Affairs Institute (IAI) in Rome, the International Institute for Strategic Studies (IISS) in London, the Peace Research Institute (HSFK/ PRIF) in Frankfurt, and the Vienna Center for Disarmament and Non-Proliferation (VCDNP), in close cooperation with the European External Action Service (EEAS) and the Foreign Policy Instrument (FPI) of the European Commission.

The Consortium and the Network aim to support the EU action to advance non-proliferation and disarmament. The mandate of the Consortium and the Network covers issues relating to weapons of mass destruction (WMD) but also to conventional arms, including small arms and light weapons (SALW).

The Consortium works through the organization of expert meetings, a major annual international conference, ad hoc seminars, the development of a dedicated website and various types of publications. It provides the EU with ad-hoc expertise and offers educational tools such as e-learning courses and internships. It also conducts various next generation activities, including a mentorship programme for young women. Finally, it is responsible for the organization of proliferation awareness trainings for specialists in natural sciences and other relevant fields and the arrangement of annual study visits to Brussels for participants in the UN Programme of Fellowships on Disarmament.

The Foundation for Strategic Research (FRS) was founded in 1998. It is an independent research centre and the leading French think tank on defense and security issues. Its team of experts in a variety of fields contributes to the strategic debate in France and abroad, and provides unique expertise across the board of defense and security studies.
